The minutes of the Supervisors of the Checklist for the Town of Londonderry

Chairperson Kristin Grages called the meeting to order at 6:00pm. Present were Supervisors Kristin Grages and Barbara MacDonald.

With gratitude for his service to Londonderry, the Supervisors reviewed the accepted resignation of Supervisor Brian McCurley, effective December 4th. The Supervisors reviewed potential appointees and the process required ahead of the March Town Election.

The Supervisors reviewed and entered new voters, reviewed and amended existing voters for name, address and party changes, and reviewed evidence from the HAVA database, the NH Department of Vital Records, the Londonderry Town Assessors office, and formal notice from other States to remove voters. The full count and names are included below as attached. The Supervisors printed out a list of removed voters to be used to organize the physical voter files. All voter records removed from the active files will be retained for seven years.

The Supervisors processed domicile proof for voters who provided it upon receiving a 30-day letter and removed the remainder of the 30-day letter recipients.

The Supervisors sent 33 voters 30-day letters to voters they believe are no longer eligible to vote.

The Supervisors will next meet on January 17th, January 23rd and February 12th.

Kristin Grages motioned to adopt Rules of Procedure for the Supervisors of the Checklist. Barbara MacDonald seconded. All voted in favor. These Rules will be effective at the next session of the Supervisors of the Checklist on January 17th.

Kristin Grages motioned to approve the minutes from the November 17th session. Barbara MacDonald seconded. All voted in favor.

Kristin Grages motioned to approve the addition or amendment 55 of voters. Barbara MacDonald seconded. All voted in favor.

Kristin Grages motioned to approve the removal of 148 voters due to death, 30-day notice, registering outside of Londonderry or voter ineligibility. Barbara MacDonald seconded. All voted in favor.

Kristin Grages motioned to adjourn at 8:05pm. Barbara MacDonald seconded. All voted in favor.

RULES OF PROCEDURE
Supervisors of the Checklist
TOWN OF LONDONDERRY, NH

1. AUTHORITY

1.1. These rules of procedure are adopted under the authority of New Hampshire Revised Statutes Annotated (RSA) 676:1.

2. MEMBERS

2.1. Per the Londonderry, NH Town Charter (Article 2, Section 2.3, A): The Supervisors of the Checklist shall consist of three (3) members, each of whom is elected to a six (6) year term (and until their successors are elected and qualified) on a staggered basis so that one (1) Supervisor is elected at each odd year Town election. The Supervisors of the Checklist shall have such powers and duties as are specified under New Hampshire law.

2.2 Selection, qualification, term, removal of members, and filling of vacancies shall conform to RSA 669:64

2.3 Each newly appointed (including re-appointed) member shall be sworn in and take an oath of office as required by RSA 42:1.

3. OFFICERS

3.1. The officers of the Board shall be as follows:

3.1.1 Chair: The Chair shall preside over all meetings and hearings; shall prepare an annual report; and shall perform other duties customary to the office.

3.2 The officers of the Board shall be elected annually during the month of March after the annual Town elections by a majority vote of the Board. If requested by a majority of those present, voting shall be by written ballot.

3.3. Per Londonderry NH Town Charter, The Supervisors shall elect a chair for a term of two (2) years.

4. MEETINGS

4.1. Meetings will be held as required by statute and as need requires, as determined by the board.

4.1.1 Meetings will be located in the Town Clerk's office or at the polls on Election Day unless otherwise posted.

4.1.2 Meeting will be posted and open to the public in accordance with NH RSA 91-A:2 ,II.

4.2.1 Non-public working sessions shall be held periodically at Town Hall for the purpose of completing clerical work including but not limited to data entry, filing and election preparation.

4.2.2 Non-public working sessions may be attended by less than a quorum of the Board.

4.2.3 No board business shall be conducted at non-public working sessions.

4.2.4. Nonpublic Sessions shall be held only in accordance with RSA 91-A:3.

4.3. Special meetings may be called by the Chair, with notice given at least 48 hours in advance of the time of such meeting. The notice shall specify the purpose of the meeting.

4.5 Quorum: A majority of the membership of the Board shall constitute a quorum. A quorum is necessary for the Board to take any action.

4.7. Order of Business for Regular Meetings is at the Chairs discretion based on the needs of the Board.

4.8. A motion, duly seconded, shall be carried by an affirmative vote of a majority of the voting members present. Voting shall be by voice vote, unless the chair specifically requests a roll call, which shall be recorded in the minutes.

4.9 In compliance with RSA 654:7-c, no person or persons may stand or be positioned within five (5) feet of citizens registering to vote, unless invited by a potential voter or the Supervisors of the Checklist.

4.10 Public comment will only be permitted at the Chair's discretion after the completion of all other business before the Board. Priority shall always be given to conducting the business of voter registration.

5. CONFIDENTIALITY

5.1 The Supervisors of the Checklist comply with the exemptions stated in RSA 91-A:5 and those created by case law.

5.2 The voter database shall be private and confidential and shall not be subject to RSA 91-A and RSA 654:31, nor shall it or any of the information contained therein be disclosed pursuant to a subpoena or civil litigation discovery request.

5.3 The voter checklist for a town or city shall be available pursuant to RSA 654:31. Any person who discloses information from the voter database in any manner not authorized by this section shall be guilty of a misdemeanor. RSA 654:45, VI

6. RECORDS

6.1. The records of the Board shall be retained per NH RSA 33-A:3-a.

6.2. Minutes of the meetings including the names of Board members, staff members present, persons appearing before the Board, a brief description of the subject matter, and all decisions made (including the vote tally for each motion), and shall be open to public inspection within 5 business days after the public meeting as required in RSA 91-A:2 ,II.

7. AMENDMENT

7.1. These rules of procedure may be amended by a majority vote of the members of the Board.

8. ADOPTION

These Rules of Procedure are hereby adopted by a vote of the Supervisors of the Checklist on this day of
