On September 7, 2013, at approximately 9:50 PM, LPD was dispatched to Memorial Dr. for a report of a robbery. The reporting party, Eric McCann, indicated that a white female attempted to rob him and two of his friends.

The suspect was described as a white female, wearing a pink tank top and dark sweat pants. She was further described as having her hair in a pony tail. The victim reported that the suspect appeared to be intoxicated.

Officer Tim Moran, having previous knowledge of a female that lived in the area that matched the description, went to 46 Harvey Rd to attempt contact with person he had in mind. While at the address, he made contact with the female that he was seeking. Ofc. Moran reported that the female, identified as Kristy Brunet, appeared to be intoxicated. She was wearing a pink tank top and dark pants. She was also wearing her hair in a pony tail.

Brunet denied any involvement with the attempted robbery. The victims were ultimately shown a photo of Brunet. She was identified by the victims. An arrest warrant was written and signed. Brunet was later arrested. Her bail was set for \$30,000 cash. She will be arraigned at Derry District Court on September 9<sup>th</sup> at 0815 hrs. Photo attached.
