S. Breault discussed with Chief Hart the body cameras, they are waiting to find out more details around the grant for the body cameras. The main concern mentioned was the staffing issues that they are currently still having. The surplus that the police department had at the end of FY 2021, will be used to outfit the new vehicles.

c. Fire Department – Jonathan Kipp

- Reimbursement requested from FEMA -\$ 653,295.03 for FY 21
- FY 21-year end \$180k in the black. Due to cutbacks on several lines during the pandemic not knowing how the reimbursement process was going to play out.
- Awaiting information on two pending grants, The SAFER grant for four additional Firefighters 100% funding for three years and AFG grant \$200+k for equipment for the ambulances. The EMPG grant for the equipment for the EOC will be going to Governors Council soon. Expect to receive \$40,000.00 in October.
- Currently down 6 positions, it has been a struggle filling positions due to a low number of candidates available. Several interviews scheduled.
- This year we have a committee currently working on a replacement for our next ambulance. I will be going in front of the Council on the 27th to ask if we can stay with our current vendor, which is the one we have had since 1996. This is for consistency and ease of maintenance.
- Open House is scheduled for October 2, 2021. Station tours and demonstrations.

The committee quested whether the ambulances are purchased or leased. J. Kipp followed up with Chief O'Brien and received this response:

The entire fleet is on the master leasing plan. One note is, after the lease payments are completed, the department owns all vehicles.

d. Capital Improvement Plan - Steve Breault

Meeting was held on September 8, 2021. No new projects were discussed. All projects last year were pushed forward. They will present the list of projects to the Planning Board on October 6, 2021.

e. Town Council - Chad Franz and Tim Siekmann

The Town Council will be reviewing the master vehicle plan of \$1.6M.
