1 Present: Marge Badois, Chair; Gene Harrington, Vice Chair; Mike Noone, member; Bob Maxwell, 2 member; Mike Byerly, member; Richard Floyd, member; Jocelyn Demas, alternate member and Mike 3 Speltz, alternate member 4 5 Absent: Deb Lievens, member; Susan Malouin, alternate member; and Town Council liaison member 6 7 Also present: Amy Kizak, GIS Manager/Comprehensive Planner and Beth Morrison, Recording Secretary 8 9 Marge Badois called the meeting to order at 7:30 pm. 10 **Unfinished Business** 11 Hickory Hill/Eversource: M Badois informed the Commission that there are no new updates. She 12 forwarded the article about ATVs in the Londonderry Times to Eversource. 13 **DOT land:** M Badois told the Commission that there is nothing new to report. 14 Gilcreast Road - Orchard Soil Testing: M Speltz told the Commission that New Hampshire Department 15 of Environmental Services (NHDES) said the next step would be performing soil tests across the 16 property, for roughly 90 samples. He said that once that is done and analyzed, NHDOT can come up with 17 a remediation plan. 18 **Monitoring:** M Badois told the Commission that there was nothing new to report. 19 WRMPP: M Speltz told the Commission that he met with Amy Kizak, Town Planner Mailloux, M. Noone, 20 and M. Badois last week, and sent out an email to Commission members reporting what was discussed. 21 He commented that the original table he created in an earlier draft has been expanded, to show a 22 responsible agency and supporting agencies, noting the responsible agency will have to come up with an 23 action plan. He stated that the next step will be for Town Planner Mailloux to take the implementation 24 plan to Kevin Smith, Town Manager, to make sure that he agrees with it. He said that Town Planner 25 Mailloux will meet with other town departments, who have a stake in the plan, to get their agreement 26 to the approach as well. He mentioned that once an agreement has been made on the plan, it would be

presented to Town Council. He pointed out that the Commission is the lead on at least one action item

and supporting on at least four or five action items. M Badois remarked that the Commission is primarily

30 **Articles for the Londonderry Times:** M Badois told the Commission that she believes they are current 31 with the articles, but would check with D Lievens. 32 Pollinators: M Badois said the presenters would be at the next meeting on March 24, 2020. 33 Bird Walk: M Badois informed the Commission that these bird walks are a college course. She said that 34 she emailed Tom Brighton, who is coordinating this, to make ask if the May 23, 2020, bird walk is a 35 scaled down model for non-participants or part of the course. She stated that Tom Brighton told her this 36 walk would probably be part of the course. J Demas commented that this will be tough for people who 37 just want to go and take a walk. M Badois added that she feels that it would be tough to tell people that 38 they have to buy a book before the walk. G Harrington pointed out that it would also be limited to 25 39 people. M Badois said she would get back to the Commission about this. 40 Trail Day: M Byerly informed the Commission this would be on June 6, 2020, which is National Trails 41 Day. M Byerly said that Trailways is having volunteers replace log bridges. M Badois asked if needed to 42 be raised up. M Byerly said that he does not think so at this time. 43 Trail Blazes: G Harrington asked if some of the trail blazes should be repainted in the Musquash. J 44 Demas responded that they do. B Maxwell commented that the Girl Scouts did this some years ago. M Badois suggested this could potentially be a new project for an interested group. M Speltz asked if the 45 46 Commission should allocate money for this. M Byerly remarked that he would like to ask Trailways if 47 they would like to do this before allocating money. 48 Bear Meadow: M Badois told the Commission that David Ellis researched Bear Meadow and found that 49 it is actually called Caudwell's Meadow. She said that now she is unsure what name is correct. G 50 Harrington said that he would need to look at the original ordinance to verify this. A Kizak took the email 51 from M Badois stating she would do some research and get back to the Commission. 52 **AOT permits:** M Badois told the Commission that she received an email from NHDES about looking into 53 changing some of the approaches to Alteration of Terrain (AOT) permits. She noted in particular they are 54 looking at addressing threatened and endangered species in a better way. M Speltz asked if NHDES 55 wants a response from the Commission. M Badois answered that NHDES will be looking for public input 56 at some point in the future. 57 Middle School: M Badois informed the Commission that she received an email from the assistant 58 principal at the middle school about taking the eighth graders that will not be attending the trip to 59 Washington D.C. over April vacation on a hike in the Musquash. She noted that there will be 50-70

eighth graders for this possible hike. She mentioned that she thought of coordinating with David Ellis to

- 63 Monitoring report: M Byerly asked if the Rockingham County Conservation District (RCCD) monitoring
- report on the Merrill property has to be done by RCCD, or if the Commission could do it. G Harrington
- 65 commented that RCCD does not charge the Commission for the report, as RCCD holds the easement.
- 66 **Stream Brochure:** A Kizak told the Commission that the stream brochure has been created in a draft
- 67 form. She said that she is looking for the Commission to send her pictures of Londonderry streams or
- properties to be used in the brochure. M Noone said he would look for the copy where the wording was
- 69 changed to be more relevant to Londonderry and send that to A Kizak. He added that he would contact
- 70 a local photographer to see if the Commission could use her photos in the brochure.
- 71 M Badois appointed M Speltz to vote for D Lievens.
