The Meeting was called to Order at 7:00pm.

New Business:

1. Stuart Ormsbee from Colonial Power Group, Bart Formith from Freedom Energy Linguistics and Mark Capidona.

--The Energy Efficiency Task Force did not know we already had an agreement in place as a Town. We have a five year agreement with them. It was signed under Kevin Smith.

--The program is currently not active. A Resident will not see any effects from this until it is approved by the PUC.

--The current rate is at 22.5 cents per kw.

--They are currently waiting on PUC Approval.

--They are looking a March 2023 to start depending on the rates.

--Mike let us know that the contract and documents are currently on the Town website.

--This agreement gives us local control. Size of the group does not matter. The main factor is time of use and how much load is needed during that time.

--Their fee is built into the rate, it cost Londonderry noting extra.

2. Rachel Eades from ReVision Energy

--An employee owned company that installs Solar projects. They are a Certified B Corp.

--Solar energy has the ability to power the entire world

--They install and maintain the solar projects. They have several different agreements that can be specific to Londonderry.

--Solar panels can go on flat roofs, pitched roofs, large open areas.

--They are currently working with Keene, Dover, Durham, Hanover

--There are several option to purchase the panels. A Power Purchase Agreement is the most popular option. \$0 upfront cost.

--They would evaluate all building and see if they would be viable. They look at roof structure, building condition and are willing to work with any different structures.

--Our goal is to get Londonderry to Net Zero.

--Discussed getting 3 bids and possible a warrant article

--Alan discussed how he came to Londonderry, what he does for the school system and his knowledge of the school systems.
