ORDINANCE 2006-10
AN AMENDMENT TO THE MUNICIPAL CODE
RELATING TO THE SEWER RENTAL CHARGES

the Town of Londonderry provides municipal sewer services to a number of residential, commercial and industrial properties throughout the community; and,
the Sewer Division is self-funded through a system of sewer use and access charges; and,
these charges need to be updated periodically to insure that the costs of operating the system, including wastewater treatment charges from the Town of Derry and City of Manchester, are totally funded through sewer fees;

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Londonderry that the Municipal Code of the Town of Londonderry, Title IV – Health, Safety & Welfare, Chapter IX – Sewer Ordinance, Section XIII – Sewer Rental Charges, is hereby amended as attached.

Chapter IX - Sewer Ordinance

SECTION XVII TARIFFS

A. Sewer Rental Charges - The following sewer rental charges shall be in effect unless amended by further action of the Town Council:

1. Service charges are payable at the following rates per quarter:

B. User charges for industrial establishments shall be as established and adjusted periodically by the Town Council:

<u>Rate (Base)</u>	<u>Billing Date</u>
\$166.40	January 1, 2007
\$176.80	April 1, 2007
\$187.20	July 1, 2007

Said base rate shall include wastewater volumes up to 9,400 cubic feet per quarter.

Flows in excess of 9,400 cubic feet per quarter shall be charged at the following rate:

<u>Rate (per 100 cf)</u>	<u>Billing Date</u>
\$1.81	January 1, 2007
\$2.17	April 1, 2007
\$2.52	July 1, 2007

C. User charges for Residential and non-metered Commercial premises shall be as established and adjusted periodically by the Town Council:

<u>Rate (Base)</u>	<u>Billing Date</u>
\$85	January 1, 2007
\$90	April 1, 2007
\$96	July 1, 2007

D. User charges for metered Commercial premises shall be as set forth in Section XVII.C.

Said base rate shall include wastewater volumes up to 3800 cubic feet per quarter.

Flows in excess of 3800 cubic feet per quarter shall be assessed a flow charge as set forth in Section XVII.B.

E. In the case of non-metered premises, the average consumption for comparable structures as determined by the Chief Sanitary Engineer of the Town of Londonderry shall be used as a basis for billing. Such owners may have metering facilities installed at their own expense. ***Town of Londonderry, NH Title IV – Health, Safety & Welfare Revised 11/06/06***
