ORDINANCE 99-18

AN AMENDMENT TO THE ZONING ORDINANCE RELATING TO THE NATIONAL FIRE PREVENTION CODE

WHEREAS the Londonderry Planning Board has voted to amend the Zoning Ordinance, particularly, that section related to the Fire Prevention of the Town of Londonderry; and

WHEREAS the Londonderry Town Council is vested with the power to effect such changes to the Zoning Ordinance; and,

WHEREAS the Town Council recognizes that such code changes would be in keeping with maintaining an updated code for enforcement purposes in the Town of Londonderry by the Town's inspectors;

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Londonderry that the Zoning Ordinance is hereby amended to adopt said changes to the National Fire Prevention Code as presented herein.

NATIONAL FIRE PREVENTION CODE AMENDMENTS

The NFPA 54, National Fuel Gas Code 1992 Edition, Replace with the 1999 Edition, with the following deletions and insertions:

A. NFPA1, NFPA Fire Prevention Code, replace 1992 edition with the 1997 Edition with the following amendments:

1. Delete 1-7.1 through 1-7.5 and replace with the following:

“1-7.1 - The Board of Appeals shall be the Londonderry Zoning Board of Adjustment”

B. NFPA 10, Standard for Portable Fire Extinguishers, replace 1994 Edition with the 1998 Edition

C. NFPA 13, Standard for the installation of Sprinkler Systems, replace the 1994 Edition with the 1996 Edition.

D. NFPA 13D - Standard for the Installation of Sprinkler Systems in one and two-family dwellings, replace the 1994 edition with the 1996 edition.

E. NFPA 13R - Standard for the Installation of Sprinkler Systems in residential occupancies, replace the 1994 edition with the 1997 edition.

G. NFPA 58 - Standard for the Storage and Handling of LPG, replace 1992 edition with the 1998 edition.

H. NFPA 70 - National Electrical Code, replace 1993 edition with the 1999 edition.

I. NFPA 72 - National Fire Alarm Code, replace 1993 edition with the 1996 edition.

J. NFPA 96 - Standard for Ventilation Control and Fire Protection of Commercial Cooking Equipment, replace 1994 edition with the 1998 edition.

K. NFPA 211 - Standard for Chimneys, Fireplaces, Vents and Solid Fuel Burning Appliances, replace 1992 edition with the 1996 edition.

L. NFPA 101 - the Life Safety Code, replace 1994 edition with the 1997 edition.

M. BOCA National Building Code, replace 1990 edition with the 1999 edition, with amendments as adopted in the Londonderry Building Code.

N. BOCA National Fire Prevention code, replace 1990 edition with the 1999 edition.
