### APPROVAL OF MINUTES

#### **UNFINISHED BUSINESS**

Rt 128 @ Pillsbury Road – Public Works Director Czyzowski advised the committee that the State has adjusted the lights, times were changed.

<u>Mammoth, Page & Grenier Field Roads</u> – Public Works Director Czyzowski advised the committee that his office has installed stop lights at the intersection. As a vehicle approaches the intersection, from Mammoth Road, a sensor goes off creating a blinking light to warn the driver to stop at the upcoming intersection.

<u>Pasquale's - Route 102</u> – Motion made by Chief Hart to take this matter off the agenda. Seconded by Public Works Director Czyzowski 5-0-0

<u>High Range & Alexander Road</u> – Chief Hart advised the committee that the statistics given to him by Captain Bernard report that the vehicles are travelling at a reasonable speed. The department will continue to monitor with radar details.

Motion made by Chief Hart to table this issue to the October 7, 2019 meeting Seconded by Member-At-Large Brown 5-0-0

<u>Litchfield Road</u> – Chief Hart made a motion to move this issue to the October 7, 2019 meeting. Seconded by Public Works Director Czyzowski 5-0-0

It was suggested to Mr. Vinitsky of the Londonderry Times to write an article for the residents explaining "no trucking" in the Town. The Ordinance can be found on the Town website.

<u>High Range & Cross Road</u> – Chief Hart advised the committee that the Police Department has been in the area, with running radar, stops were made and warnings issued. Overall the average speed was 34 mph. Chief Hart advised he will continue to monitor.

#### **NEW BUSINESS**

<u>Seasons Lane</u> – Ms. McNeil discussed the speeding complaint on Seasons Lane, along with the foliage. A discussion followed and the foliage will be trimmed by the Highway Department. The traffic issues are during the day, evening and weekends. Chief Hart advised he would ask supervisors to schedule attention to the area. Ms. McNeil advised they have a web page for Seasons Lane residents.

<u>Shasta Drive</u> – Discussion took place regarding the signs on both sides of Shasta Drive by Nutfield Country Store. Trucks are parking on Shasta creating a traffic hazard to vehicles going in and out of the parking lot.

Chief Hart made a motion to remove the "no parking" signs going east from the driveway to Mammoth Road, and an additional "no parking" sign put up at the second driveway going west.

Seconded by Battalion Chief McQuillen

Smith Lane – A discussion followed regarding Smith Lane and the intersection at Routes 28 and 128. Public Works Director Czyzowski advised the committee that this intersection is on the 10 year plan with the State. He will contact District 5 regarding the hole from Rockingham Road (Rt 28) onto Smith Lane, reflectors have been knocked down creating a hazard at night.
