**OLD BUSINESS**

Belgian Way - Intersection of Route 102 @ Old Nashua Road – Director Trottier made a motion to table this until April of 2023. Developer of 21 - unit single family development is required to perform a traffic study which will look at the current and future operations of the intersection.

Boyd, Parmenter and Old Nashua Roads – Asking for stop sign correction.

Director Trottier has investigated the area and feels that the DPW can remedy the problem by painting "Stop Ahead" on the pavement to warn of the approaching intersection. This will assist the inability to see the stop sign at the intersection because of the hill on the road. No further action is needed.

## **NEW BUSINESS**

Rebecca Drive – Dead end sign requested by residents who are experiencing traffic mistaking Rebecca Drive as a way to exit to Route 102. Problems caused, in part, by traffic blockage on other roads in the area. People speed out of the road when they realize that it has no outlet to Route 102.

Director Trottier suggested a Dead End or No Outlet to Route 102. He will investigate and take the appropriate action.

Director Trottier made a motion to remove Rebecca Drive from the agenda.

Old Mammoth Road - Brian Mead is an Old Mammoth Road resident who is concerned about speeding on his street. He talked about the problems of speeding and ignoring the stop signs on Old Mammoth Road. He mentioned speed, labeling of the road surface and other solutions. Mike Malaguti explained that the board should expand the availability of some new ways to improve the situation. He will meet with members of the board.

Mike Malaguti made a motion to table until April 3, 2023.

Seconded by Director Trottier.

Boulder Drive – Chief Bernard spoke to the problem of speeding through Boulder Drive. Residents spoke of their concerns with the speeding through their neighborhood. Director Trottier will be checking on the presence of speed limit signs and what the actual speed limit should be. Residents feel that because this is a road through a condo development the speed limit should be 10 miles an hour. One question asked was “could residents take over as a condo development”? Town Manager, Mike Malaguti, referred to RSA 231.45. Implementation of this RSA could have unintended consequences. Further study is required.

Director Trottier made a motion to table until April 3, 2023.
